TAX CONCESSIONS

Council recently passed its 2017 tax concession policy which provides for the cancellation of municipal property taxes on certain new construction and commercial properties. The concessions are available over a three- year period, but are not available to properties in tax arrears.

Make snow removal easier

The Town of Canora is asking for assistance from local residents to maintain its efficient snow removal. After a major snowfall, residents should, when possible, limit on-street parking until streets are cleared. Please be reminded that Canora has a 24 hour parking bylaw that includes all vehicles and trailers. Residents should know that they are prohibited from clearing or removing snow from private property onto a street, lane or other Town property. The exception to this is downtown, in the areas where snow is moved to another location. In these areas, snow from sidewalks only may be cleared onto the street. Snow from private parking lots should not be pushed onto the street. Downtown sidewalks and streets will be cleaned by Town crews only after a major snowfall. Whenever possible, highways, primary streets and those to the hospital, fire hall, ambulance and schools are cleaned first. Public works employees often work 24hrs a day to ensure snow is removed from the community quickly and efficiently. The patience and cooperation of residents during this time is appreciated.

RIDING YOUR SNOWMOBILE AROUND TOWN:

Snowmobiles may be driven within town limits between 8 a.m. and 12 midnight.

They are not permitted on Main Street or the provincial highways, except for the purpose of crossing.

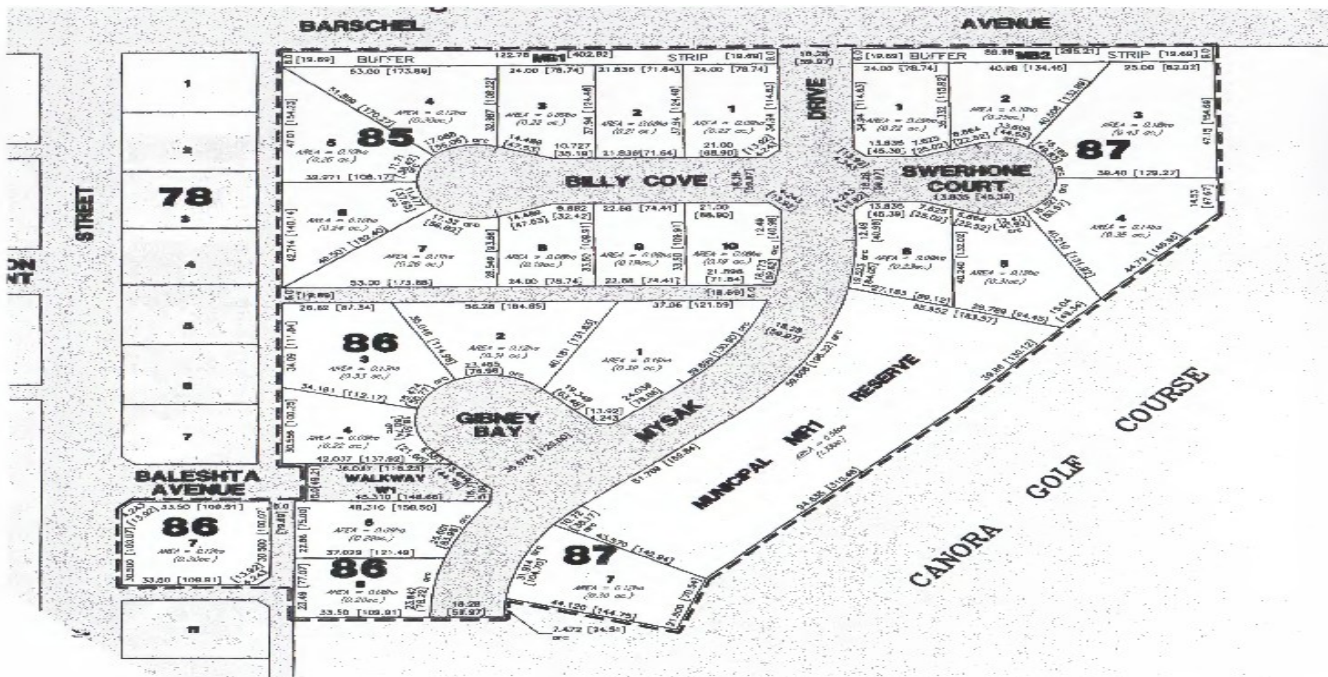
Canora still allows snowmobiles on it's streets. Please cooperate with the bylaw and drive responsibly to ensure the privilege is continued.

Owners should not allow their dogs to create a nuisance by barking. And, if a dog defecates on public or private property, its owner must dispose of the mess immediately, in a sanitary manner. Owners are required to regularly remove dog litter from their property as well.

Contravention of the above can result in a monetary fine or impoundment of animals.
